#### **CEO REPORT**

#### **Capital & Building Projects**

# **Capital Projects Planned for FY 2024**

In January 2023, the County Administration decided to postpone capital projects originally planned for FY 2024, including the Bel Air Renovation Project. In May 2023, the County Executive provided a confirmation letter, certifying a local minimum match of 45% for the Bel Air Library Renovation Project. Additionally, the County has allocated \$575,000 in FY 2024 County Capital Funds for the Bel Air roof replacement. The County made the decision to not use the County Library Capital Grant funds for either the roof replacement or the elevator replacements because of prevailing wage requirement. The Library has submitted the Bel Air Renovation Project as part of the Capital Budget for FY 2025. During the 2024 Legislative Session in Annapolis, the County Library Capital Grant program hearing was held in February and several Delegates questioned why Harford has not spent/used any of the library capital grant funding they have been granted for the Bel Air Library Renovation Project.

#### **Abingdon**

The Library Team engaged with the County to address persistent roof leakage issues. The primary areas requiring attention are the coping and flashing. Garland/DBS, Inc. has been contracted by the County to work on coping replacement and redoing the sill plate and caulking. Work on the north side of the roof, focusing on coping and flashing replacement/redoing, commenced on July 3rd as a test to resolve ongoing leaks in that area. Facilities will monitor this section for the next six months. If successful, the rest of the roof will undergo similar treatment. Despite ongoing efforts, additional leaks have occurred during recent storms. The County utilized drones and thermal imaging to inspect the roof the week of January 2<sup>nd</sup> for further analysis of the continued leaks. Facilities is waiting to receive the results of the test.

Abingdon's security camera system has been replaced. The vendor is finishing the programming of the system. The decking to and around the pond is scheduled to be replaced in the spring by the Department of Parks & Recreation.

#### **Edgewood**

The County has informed the library about the use of balances from a Community Development Block Grant (CDBG) to repave the Edgewood Library parking lot. The total eligible funding for the project is \$166,886.21. A recent pre-bid meeting was held, and the county has determined that if the ADA ramp in the back of the building is retained, the parking lot project will not proceed, and funding will not be available. The Library insists that the ADA ramp is crucial for staff and HCC access to the classroom wing. This project is on hold until warmer weather arrives, and the asphalt plants reopen in the spring. The bid process will begin promptly and the project includes ADA accessible access for the both the front and back of the building.

#### **Fallston**

Sidewalks are scheduled for repair/replacement. Further details, including a start date, are awaited. There may be a need to temporarily close the branch for part of the repair.

#### **Havre de Grace**

A replacement security camera system is on order and will be installed as soon as it has been received. Facilities is looking at options for the branch's street corner signage. The Havre de Grace Friends is contributing to the cost of the sign. The Library is getting an estimate on the additional masonry work and safety features required in order to install a manual sign.

#### Administration

The library is exploring the possibility of installing a new electric gate in the back parking lot. Currently, library staff must manually close the gates and padlock at closing.

#### **Board Updates**

Trustee Shannon Gahs resigned from the Board, having relocated to Howard County and is no longer eligible to serve. The seat will be filled, and the new Trustee will complete Ms. Gahs' term (until June 30, 2025) and be eligible for their first five-year appointment to the Board. The Board Executive Committee has interviewed candidates for this position and forwarded their recommendation to the County Executive for consideration in December. We have not received any feedback or update on the process to date.

#### **Time to Care Act**

The new Maryland Time to Care Act (TCA) allows employers to purchase insurance to fulfill their obligations to provide TCA paid leave to employees, instead of contributing to the State Plan. The library has submitted a statement of intent to join the TCA Insurance Collaborative, along with the County. Pending legislation in Annapolis if passed, clarifies the current Act.

#### **Strategic Planning and Futures Thinking**

The Library has received two grants to support upcoming strategic planning and futures thinking. The Maryland State Library Agency has awarded \$22,500 for the Strategic Plan and \$13,000 for Futures Thinking, both supported by the Institute of Museum and Library Services (IMLS). The RFP has been completed, and an agreement has been signed with the Maryland-based Quinn Strategy Group led by Ann Quinn, Principal Chief Action Officer. Focus groups, interviews and meetings are ongoing as the consultants gather input and feedback from stakeholders. Staff have participated in two, future trainings and the project continues.

# **FY 2025 Operating and Capital Budgets**

A preliminary budget has been drafted and discussed at the Board Budget and Finance Committee and the Board Capital Improvement Committee. The Library has recommended a 4% salary increase for eligible staff, the return of teen pages for all branches (13 pages, minimum wage, and nine hours per week), and a 10% increase in health care benefits. The total proposed increase is \$1.5 million or a 6.23% increase. This reflects an overall increase of 14% for materials, 14% for operating expenditures; 5% salaries and benefits; 3% contractual services (insurance/equipment/software support; telecommunications; contract services.) The budget was submitted on February 9<sup>th</sup>.

**Harford Leadership Academy 2024** – We are pleased to announce that Arthur Squires, Director of Facilities, and Deidrah Reeves, Branch Manager Norrisville Library, have been accepted into this year's academy.

<u>Maryland Library Day in Annapolis</u> – Tuesday, February 13<sup>th</sup>, was Maryland Library Day in Annapolis and libraries from across the state visited their Delegates and Senators discussing pending legislation. One of the hot topics this year is the Freedom to Read legislation submitted by Delegate Dana Jones, Anne Arundel County. This day was also Maryland Arts Day and members of the Cultural Arts Board and arts community visited their

delegation requesting support for arts funding. On Monday, February 12<sup>th</sup>, Ms. Hastler attended the District 34 reception and evening session.

<u>Maryland Connected Device Program</u> — The Library is supporting the County's initiative to distribute 2,500 Chrome Books to eligible families. Final details are being worked out and we hope to launch the program before the end of February. Ms. LaPenotiere and Ms. Greenly Smith are taking the lead on this project for the library.

## **Programming and Events Highlights**

The Winter Reading Program at Aberdeen has been extremely popular with customers. The theme, mug, and bag have been well-received. Also, Aberdeen's introduction of weekly travel quizzes, where each completed quiz serves as an entry for gift basket drawings, has contributed to an increase of last year's registration total. Fallston's inaugural Pajamarama program experienced a great turnout. The story time segment featuring stories and songs was enjoyed by all attendees. Parents expressed appreciation for the program, including interest in future Pajamarama events.

The Family Game Night in Havre de Grace attracted both teens and families, who engaged in a variety of card and board games such as Sorry, Codenames, Azul, and Sushi Go. Attendees expressed excitement for the library to host similar programs in the future. The branch plans to revisit this initiative for the summer due to the positive response by the 21 customers.

Saturday Story Time at Joppa drew a large crowd, with positive feedback received from attendees. The promotion of the event on a neighborhood Facebook page contributed to the turnout, with one mother praising Rachel's hosting skills. Furthermore, a senior couple's completion of the WRP Passport was met with excitement as they received their prizes. They enjoyed a bowling outing, which they had not done in years. And they loved the complementary ices cream at one of the stops. They thoroughly enjoyed participating in the program.

## **Teen Services Highlights**

Despite poor weather conditions, Aberdeen's Teen Crafternoon program saw enthusiastic participation. Attendees engaged in Batik dyeing activities. This was a successful turnout despite the challenges posed by school closures and reduced library hours.

Twenty-five teens and preteens participated in Bel Air's Babysitter Training class. The program attracted the attendance of two Girl Scout troops. The session included a safety presentation delivered by the Bel Air Volunteer Fire Company.

A group of Fallston teens showcased their creativity by crafting DIY Neon Signs using wire and zip ties. Joppa teens enjoyed two activities: the Black Panther Green Screen experience and the DC vs Marvel trivia challenge. Both were very popular.

Customers at Whiteford's Modge Podge Craft and Create program had an enjoyable experience. They crafted car coasters and jars using Modge Podge, for personal use or gifting.

Teens at Edgewood's Manga Drawing Lessons program received instruction on drawing manga characters, with a focus on facial features such as hair, lips, and eyes.

## <u>Community Partnership – Harford Community Action Agency (HCAA)</u>

HCAA has programs that support our community and there is an HCAA representative scheduled to visit one HCPL location each week. #### **Foundation**

The Harford County Public Library Foundation convened for its meeting on January 23rd. The upcoming session is scheduled for February 27th at 6:30 p.m. at the Abingdon Branch.

# **Board Expansion:**

During the January session, the Foundation unanimously resolved to appoint 5 new Directors, namely Sarah Klein, Lee Tayson, Jonathan Waterhouse, Rachel Harbin, and Silvana Bowker, to the Foundation Board. Adding these directors augments the Foundation with valuable experience, wisdom, and expanded networks.

## **Digital Presence:**

Efforts are currently underway to enhance the Foundation's digital presence and materials. Our Foundation's web page is undergoing a comprehensive update to accurately reflect our mission, initiatives, and impact. This revamp aims to create a more user-friendly experience for visitors, providing easy access to information about our programs, events, and ways to get involved. In addition to our online presence, we are refining our print and digital collateral, including donor letters, board materials, and brochures, to communicate the Foundation's goals and achievements more effectively.

In addition, important updates were made to the Foundation's insurance policy in January, and a financial program through Blackbaud, the Foundation's donation software, was explored.

# **Financial Highlights:**

A total of \$32,500 has been successfully raised to bolster the 2024 Summer Reading Challenge. Projections indicate that expenses for the completion gifts and incentive bags for 2024 will amount to \$30,000.

The Foundation's Annual Giving Campaign has raised over \$12,500 in contributions to date.

#### **Upcoming Events:**

In a significant initiative, the Taste of Harford, a gastronomic event showcasing local restaurants, breweries, wineries, and agricultural partners, is slated to debut on May 19th, from 1 to 4 pm, at Vignon Manor Farm in Darlington. Collaborative partners for this event include Visit Harford, Harford County Farm Bureau, Harford County Health Department, Harford County Ag Advisory Board, and the State Department of Agriculture. Noteworthy progress has been made, with the launch of a dedicated web page, distribution of restaurant invitations, and plans underway for a publicity push at the end of the month. Anticipated ticket sales are scheduled to commence in March.

Moreover, the Foundation has submitted a grant proposal to be designated as the beneficiary of proceeds from SIAB's golf tournament while also exploring collaborative opportunities with other nonprofits for two additional fundraisers.

Looking ahead, the Foundation aspires to organize a 2024 Night out with an Author alongside an art exhibition featuring the Gala theme and works from several local artists.

## **Donor Appreciation:**

The Foundation launched a February donor appreciation campaign.
