• The emergency special enrollment period for uninsured Marylanders runs through Monday, July 15, 2020. The online application is available daily from 6 am to 11 pm - have these items ready when you apply. Assistance is available by calling 855-642-8572 weekdays from 8 am to 6 pm.
