In June, circulation was at 324,561 and information reader assistance at 45,627. There were 575 programs with 54,450 attending. There were 152,162 walk-ins and 7,302 drive thru visits. A complete report was included in the Board packet for review.

#### <u>July 2018 Programming Highlights – Beth LaPenotiere</u>

June started with the Summer Reading Challenge. Abingdon and Fallston were our Sponsor Kickoff branches. It was a wild and wonderful time! Abingdon presented two Family & Friends Story Times; Fallston had Ray Owens, the Song Imagineer. Both branches had Chalk Our Walks. By the end of June, Summer Reading Challenge registrants reached a healthy 11,609! Abingdon's Adult Department designed a quick but fun bi-weekly activity for adults to enjoy this summer. The first activity queried, 'who was your favorite band when you were age sixteen and what was the year?!' Seventy participants took that stroll down Memory Lane. Responses included: Three Dog Night and The Beatles (1966), Foreigner (1979) and Kiss (1976), The Bee Gees (1980) and Bon Jovi (1988), Beastie Boys (1992) and Nirvana (1992), The Backstreet Boys (2001 and 2004), and Boys Like Girls (2011) and One Direction (2018).

The Harford County Cultural Arts Board presented several Artists in the Library programs in several of our branches: Aberdeen hosted Puppet Making, where during four Saturday sessions attendees created dolls using a wide variety of materials. The artist also did a special sock puppet program. At Abingdon, customers had lots of fun making light sculptures, light paintings and hypnotizers. The Felted Mural Program at Edgewood was very successful. Over four session, customers and staff used felting to create a mural reflective of the Edgewood community. The completion of the mural was celebrated with a program where several participants shared both their experience of felting and what their addition to the mural meant for them. Fallston's program

was an unqualified success. The artist worked with the community to design and execute two stunning mosaic pieces that were mounted outside the library. A storyteller presented a special story time at Joppa. She followed up with two wonderful storytelling workshops. At Norrisville, the artist presented the Drawing Zoo program. It featured live animals as drawing models for the audience of toddlers through adults. She provided interesting facts about the animals as she guided the participants through their drawing activities.

The Library Book Bike attended its first event. Three staff members accompanied the bike to Shamrock Park for the Bel Air Downtown Alliance movie night. Many kids were excited to see them and they registered some for the Summer Reading Challenge!

# YA Highlights for July 2018 – John Paramore

For the teens of Harford County, the month of June was full of Summer Reading prep. Middle and high school students all around the county enjoyed visits at their schools from teen librarians, where they learned about the Summer Reading Challenge and great books they should check out throughout the summer.

Students got into the spirit of the Summer Reading theme, Libraries Rock, at Havre de Grace Middle School.

Teen Librarian, Scott Businsky, showed students the art of rapping a picture book and a select group of participants was able to impress everyone with their rhythm skills by trying it out in front of their class!

At some school visits, students were so excited about summer reading they chose to pre-register for the challenge. At Fallston High School in particular, over 100 students pre-registered for Summer Reading during the library's visit!

Teens in Harford County were excited about summer reading and volunteered to help! Early June saw hundreds of middle through high school teens trained as Summer Reading volunteers to help the library with our busiest time of the year. Not only do the teen volunteers help the library by doing this, they also gain volunteer hours and much needed skills for their college resumes and future job search.

Once Summer Reading officially started, teens enjoyed June's special summer programming at the library. The teens of Abingdon participated in a fun filled evening of juggling on June 25<sup>th</sup>. With the help of a guest presenter, the teens were able to learn how to juggle a minimum of three balls. A fun time was had by all! At the Fallston library, The Money Smart Teens program featured a guest speaker from APG Federal Credit Union who talked about the importance of good financial planning.

# <u>Chief Executive Officer's Report - Ms. Hastler</u>

## **Building Projects**

**Abingdon Window Replacement Project** – Meetings have been held with the County Administrator and County Facilities to review and assess the multitude of documented leaks at the Abingdon Library. A purchase order was issued to Colimore Architects to provide design expertise. Predesign work is underway and the county held

a design meeting on September 12 to review project scope and timeline. It is anticipated that the design drawings will be completed winter 2018; award the contract by June 1, 2018, and demolition/construction/replacement begin early October 2018, immediately following the Gala. The Library will be closed for approximately 8-12 weeks. Depending on the firm start date, we may request to close one week before the Gala to begin moving and storing furniture and equipment. The County Executive has included \$1.259 million for the window replacement project in the Proposed Capital Budget Program in the County General budget for FY 2019. A pre-bid meeting is scheduled for July 26<sup>th</sup>. Bids will be due back mid/late August and submitted to the Board of Estimates for approval at the September 11<sup>th</sup> meeting. It is anticipated that the project will take approximately six months from start to finish with the onsite portion of the project estimated for three months. As of mid-July, it is anticipated that the branch will close mid-November for three months.

**Jarrettsville – Gutters/Sidewalk Repair –** Gutters and downspouts have been installed. The next step of the project is to correct the pitch of the sidewalks to ensure proper drainage. The County – Parks and Recreation - has the sidewalk component on their project list and is working with the County's Capital Projects department to secure a vendor. There are two concrete slabs in the rear of the building that have settled causing low spots where water collects and freezes requiring replacement.

**Riverside Renovation** – Mary and Kathy met with the County officials and a representative from the shelter to discuss options to reallocate space at the Library's administrative offices. The County, the Shelter and the Library all share the space at 1221-A Brass Mill Road. The shelter is looking to expand to add additional beds for a total of 50. The County is considering relocating their warehouse to allow for the expansion. The Library would benefit from the space utilization study to better align the departments and optimize the space we occupy. The Library team has visited several businesses and nonprofits gathering ideas for the renovation project. Frederick Ward Associates were selected by the group to prepare the design. Planning continues to develop for a more efficient work space.

**Fallston** –The roof developed many leaks during the winter and continue. Temporary measures to catch the water were installed by the County until permanent repairs could be made. The County is preparing an RFP. A pre-bid walk through at the branch is scheduled for June 18<sup>th</sup> in the morning. Bids are due by July 3<sup>rd</sup>. Work is anticipated to begin in September.

**Aberdeen Children's Area Refresh** - The Library is currently reviewing drawings to refresh the Aberdeen Children's area. The refresh would include new shelving, furniture, and carpet. Also under consideration is upgrading the lighting for the space.

**Facilities Master Plan** – The contract was awarded to HBM Architects, LLC, from Cleveland, OH. The consultants toured the branches during the onsite visit on April 4 and 5<sup>th</sup>. We will review the first draft of the report on June 27<sup>th</sup>. A Community Discussion was held that same evening at the Abingdon Branch. A meeting to review the second draft of the plan is scheduled for July 26<sup>th</sup>. The report is scheduled to be completed by the end of September 2018.

<u>Choose Civility Harford</u> – Choose Civility Harford's kickoff was held on Wednesday, June 27<sup>th</sup>, at Waters Edge with keynote speaker, Valerie Gross. County Executive Barry Glassman spoke on the importance of Choose Civility Harford and encouraged everyone to be part of the movement. More than 275 community representatives attended and were introduced to the concept of Choose Civility. Each attendee received a welcome package with information on how to register as an Affiliate and more. Feedback has been very positive. The Library has planned several events and activities under the auspices of the Choose Civility movement.

# Cultural Arts Board – July 2018

**Artists in the Library** was a series of free high-quality community-based arts experiences led by Maryland-based professional teaching artists throughout June 2018 at eight locations of Harford County Public Library. These community projects invited all generations to work side-by-side and ignite their creativity together in all corners of Harford County.

The series kicked off with a Unified Jazz Ensemble performance at the Cultural Center at the Opera House in Havre de Grace. The group returned for three hands-on improvisation workshops at the HdG branch. Other programs included the following:

- mixed-media hand-sewn puppets
- Community Light Lab Days presented by FutureMakers –combining light with 2D and 3D art projects e.g. light sculptures, building and painting with a light paintbrush, and hypnotizers (spinning glowing machines).
- Edgewood, Fallston, and Jarrettsville Libraries each hosted a collaborative visual art project that will become a permanent fixture at each location.
  - Edgewood community worked with fiber artist, Katherine Dilworth, to create a felted mural
  - Fallston community worked with Sue Stockman and Sequoia Chupek to create mosaics
  - Jarrettsville community wove Peace Wheel, while learning songs and stories of peace from around the world, and children were invited to build jug band instruments out of recycled objects, then play and sing along with the Sunnyland Band.
- Joppa has an actress/storyteller for an interactive performance by the artist, and then returned to teach workshops on the traditional African art of storytelling
- Norrisville had the Drawing Zoo, who brought live animal models for drawing class models

Harford County Cultural Arts Board also presented a series of art exhibitions and free events June 25 – 30 focusing on removing the stigma of substance use disorders and other mental illnesses - **Hurting, Healing, Feeling, a New Day Campaign project**. This series of events brought together disparate community stakeholders and artists to partner with us including Office of Drug Control Policy, Ashely Addiction, Aberdeen Proving Ground, Maryland Coalition of Families, regional partners Vet Arts Connect and Institute for Integrative health, local businesses Love Evolution Studios and Julie Ellyn Designs. More than 800 people of all ages attended the June programs and events.
